The Pact for Skills is a shared engagement and approach to skills development. It is firmly anchored in the principles of the European Pillar of Social Rights (https://ec.europa.eu/info/strategy/priorities-2019-2024/economy-works-people/deeper-and-fairer-economic-and-monetary-union/european-pillar-social-rights_en) and supports the goals of the Green Deal (https://ec.europa.eu/info/strategy/priorities-2019-2024/european-green-deal_en) and the digital transformation (https://ec.europa.eu/info/strategy/priorities-2019-2024/europe-fit-digital-age/shaping-europe-digital-future_en), as set out in the Commission communication "A strong Social Europe for Just Transitions (https://ec.europa.eu/commission/presscorner/detail/en/ganda_20_20)".

 Commitments must be in line with the key principles and can be built around a number of "enablers" that illustrate concrete ways of implementing the different principles.
- 3. Commitments are monitored by at least one key performance indicator, e.g. number of people taking part in upskilling or reskilling.
